- 2. The proceedings of the meeting including the action taken by the states in compliance of the directions of CoRS and their detailed action plan for reducing road traffic fatalities and injuries is to be filed before the Hon'ble Court before the next hearing on 19<sup>th</sup> Sep 2016.

## Agenda for the Meeting under the Chairmanship of Secretary (RT&H) to take stock of the compliance of directions issued by the Supreme Court appointed Committee on Road Safety (CoRS) at 02.30 P.M. on 02.09.2016

Action taken report on Compliance of the Important Directions of CoRS to the States

- (i) Formulating/adopting a road safety policy.
- (ii) Action Plan for reducing road crash fatalities and injuries.
- (iii) Activate State Road Safety Council and hold its meetings at least twice in a year.
- (iv) Establish a Lead Agency in the State with adequate dedicated and professional staff to deal exclusively with road safety issues.
- (v) Establish Road Safety Fund by making available a portion of the fines collected from traffic offences to the Fund and also make adequate provisions in the budget for meeting expenses on road safety.
- (vi) Implement directions of the Hon'ble Court on Road Engineering as contained in its Judgement dated 22<sup>nd</sup> April 2014.
- (vii) Rectify immediately all Black Spots identified since 2011.
- (viii) Draw up a Protocol and an annual calendar for identifying Black Spots and their removal and further monitoring to see the effectiveness of the action taken.
- (ix) Carry out road safety audits during design, construction and operation of roads and implement recommendations of the Audit.
- (x) Undertake construction of road beyond Rs 10 crores only after Design Audit is completed and its recommendations implemented.
- (xi) Adopt traffic calming techniques at locations where accidents are occurring due to over-speeding.
- (xii) Suspend driving license for not less than 3 months under Section 19 of MV Act and Rule 21 of CMVR for over speeding, red light jumping, use of mobile phones while driving and over loading.
- (xiii) Make use of helmet compulsory both for main and pillion riders
- (xiv) Tighten procedure for issue of permanent driving licenses. Commence action in a time bound manner for establishing sensor based computerised driving tracks to eliminate human intervention for issue of permanent driving licenses.
